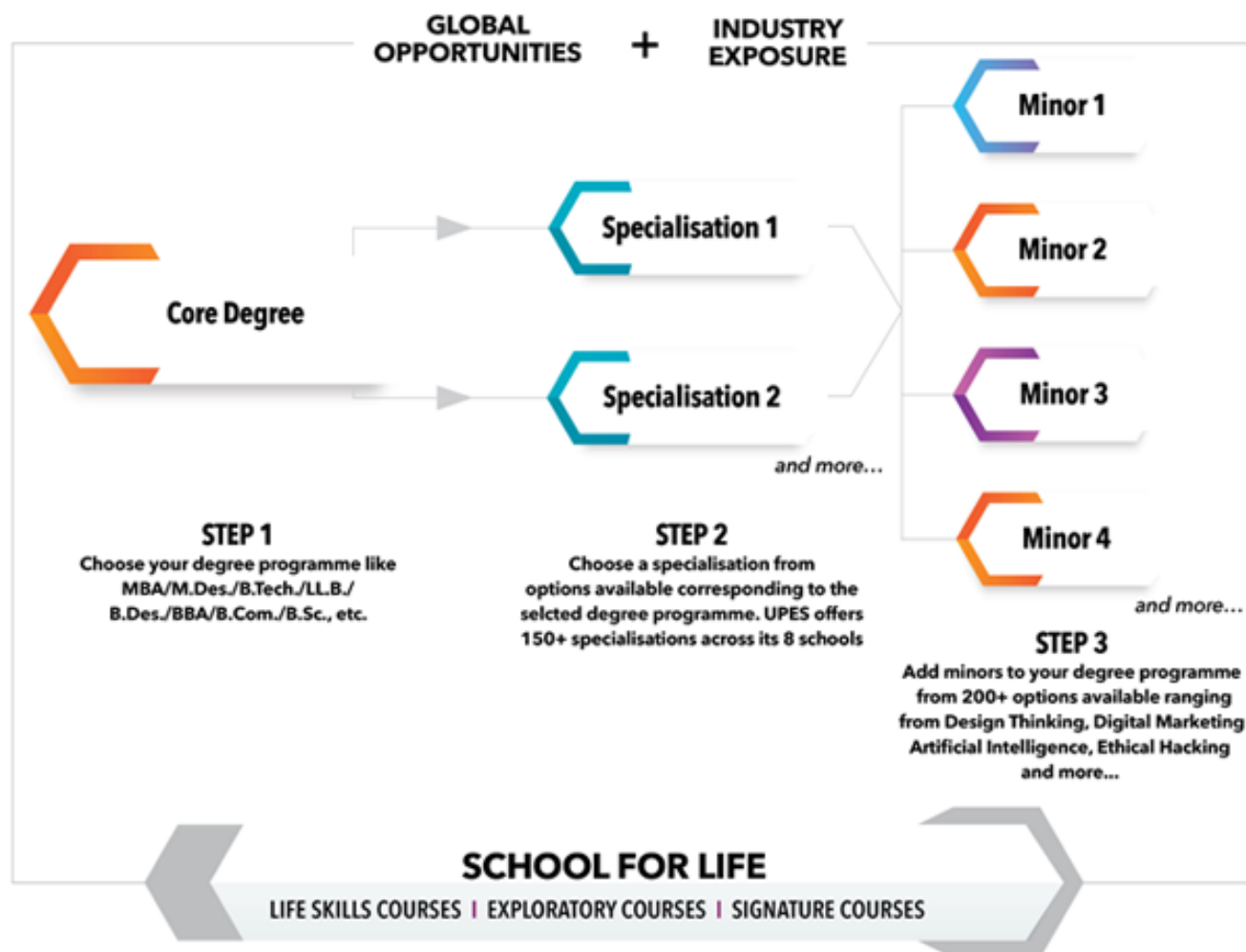

Training and Certification Fee: To give real life exposure to students and to make them industry ready professionals, short duration industrial tours/training and/or online trainings shall be organized for all students of full-time programs,

The trainings may lead to certification in all programs Except for Engineering PG, Law PG and B.Com / B.Sc. & Pharma students where it will be a credited course. A charge of Rs. 28,000/- (one time) is to be paid in 5th semester in case of UG Programs and 2nd semester in case of PG student. In case travel of industrial tour by air is necessitated, additional charges, if any, would be intimated to the students concerned for payment prior to commencement of the tour. For BBA Students they must pay this amount along with 3rd Semester fee.

19. STUDENT FINANCIAL SUPPORT

The University has extended a financial support to the students who are unable to pay the tuition fee on account of having lost any of the earning parents AFTER TAKING ADDMISSION AT UPES AND AFTER SUBMITTING FULL FEES FOR ATLEAST ONE SEMESTER.

Amount Given as Support:

- The financial support extended by the University is a relaxation of Rs 50,000/- towards their tuition fee per semester till the last qualifying semester.

Eligibility Criteria:

- The student should maintain / improve their academic performance every semester.
- The students applying for relaxation should not have any NC (Not Clear) or Backlog in any semester. However, the scholarship committee can use its discretion can recommend the Vice Chancellor for approval without using this as a precedent for future cases of the same nature if any.
- He/ She should also have a clear record on discipline background.
- This relaxation is applicable only for the upcoming semester.

Applicable Conditions:

- The above relaxation is only for one semester.
- Students desirous for the extension in next semester will be required to submit fresh application along with the grade card of last exam passed once a communication is circulated by the department of Student Engagement and Experience.
- The Committee reserves the final right to approve an application received from the students.

20. ALUMNI SCHOLARSHIP

- Applicable to all Alumni graduated from 2019 onwards. For any Alumni graduated before 2019, department of alumni relations will present the case to the scholarship committee for special approval.
- Alumni have to meet the notified eligibility criteria for AY 2024-25 for the respective programs.
- Should not been awarded grade F or improvement in any of the course/paper in any of the semesters.

Admission Criteria:

- Alumni have to directly apply online and have to email his/her academic details along with application number.
- Alumni have to go through the admission process of the applied program as per the notified selection process for AY 2024-25.
- Alumni will have to clear the selection process.

Offered Scholarship:

- Applicable on only 50% tuition fee waiver for the full duration of the program. Rest all fee components to be charged as per the notification of AY 2024-25.
- No other scholarship will be offered or clubbed with this scholarship
- No Alumni fee to be charged
- Renewal of the scholarship for the subsequent year will be only based on attaining minimum 8 SGPA /CGPA with no back log and no disciplinary cases registered or reported against the student.
- In case of refund applied after admissions – refund policy will be applicable for AY 2024-25.

Reservation of Seats

For Uttarakhand bona fide resident candidates: 15% of the seats in all programs will be reserved for residents of Uttarakhand subject to production of “Sthai Niwas Praman Patra” (Permanent Residence Certificate) issued by the competent authority of Uttarakhand State. These seats will get allotted based on the merit order in this category, provided the candidate has declared his intent to opt under this category at the time of applying for admission.

Note: Candidates applying under this category would be required to produce the original “Sthai Niwas Praman Patra” during the day of admission failing which their candidature shall not be considered under reservation of seats for UK domicile Category.

Seats remaining unfilled by the stipulated date in this category may be treated as unreserved.

Withdrawal of Seats

UPES follows UGC guidelines regarding refund of fees on withdrawal. The refund will be processed online. For more details on refund policy, please visit www.upes.ac.in

Transportation

Students residing at Dehradun city and wishing to avail transportation facility to the UPES campus can avail the same by paying a fee of **Rs. 26,250/-** for the academic year 2024-25.

Note: There will be No refund of transport fee in case of withdrawal.

Medical Facilities

University provides basic healthcare facilities. Doctors on roll provide basic first aid in case of medical emergencies and subsequently students are assisted in evacuating him/her to nearest hospital.

The medical treatment cost is to be borne by the student or his/her parent. The onus of medical insurance is on the student, and he/she is expected to keep insurance card handy.

Placement

UPES shall provide placement assistance to all enrolled students subject to their fulfilling eligibility conditions as prescribed in UPES Placement Regulations. However, the obligation of the University will be only to provide placement assistance and not placement guarantee.

Ragging

The University has zero tolerance policy on ragging and will strictly enforce it. Ragging in any form inside or outside the campus and hostel premises is strictly prohibited under UGC regulations on ragging, Ragging being a cognizable offence; the punishment for ragging will be summary expulsion from the University.

Ragging as defined by the Hon'ble Supreme Court of India: "Any disorderly conduct whether by words spoken or written, or by an act with the effect of teasing, treating or handling with rudeness any other student; indulging in rowdy or undisciplined activities which causes or is likely to cause annoyance, hardship or psychological or to raise fear or apprehension thereof, in a fresher or a junior student, or asking the students to do any act or perform something which such student will not do in the ordinary course and which has the effect of causing or generating sense of shame or embarrassment so as to adversely affect the physique or psyche of a fresher or a junior student."

How to Apply

Candidates desirous of seeking admission to any of the program must apply online at www.upes.ac.in or offline at admission office by paying the application form fee of Rs. 1350/-.

Commencement of Program

Commencement of actual classes begins from the date of commencement of PEP (Personality Enhancement Program) held immediately after registration.

Admission Process for International Students

An applicant holding a passport of any country other than India is defined as an international student.

A student holding an Indian passport but having qualified higher secondary examination/undergraduate degree or equivalent from a foreign country will be classified as international and apply as international student.

Students from SAARC countries - Afghanistan, Bangladesh, Bhutan, Maldives, Nepal, Pakistan and Sri Lanka, and non-resident Indians (NRI as defined above) of these countries will pay fees in line with domestic students. However, they are classified as international students and gain admittance through the international Pathway.

Parents/Guardians resident outside India have the option to sponsor their wards who have passed their secondary/university education in India through the international pathway.

Eligibility Criteria for International Students

- Students must fulfil minimum eligibility requirements as laid down for their chosen program at UPES.
- UPES must be satisfied that candidate applying for admission to undergraduate programs must have obtained higher secondary school certificate (with minimum percentage of marks as prescribed) and taken requisite courses necessary to meet the eligibility criteria for the program of admission.
- For admission to postgraduate program at UPES, the equivalence for the undergraduate degree earned by the candidate in his/her country shall be obtained from the Association of Indian Universities (AIU). In certain cases, students may be requested to obtain the necessary certification from (AIU).
- It is recommended that students have the following:
 - School of Business:
MBA programs: GMAT score of 600.
 - School of Engineering
 - School of Computer science
Undergraduate programs: Valid SAT score
Postgraduate programs: GRE Score of 1700 (cumulative).
- Students from non-English speaking countries should satisfy UPES that they have adequate proficiency in English to be able to undertake the program of their choice. If required, an undertaking from such students shall be taken to undergo the English language training for a specific period (depending on the proficiency to be assessed by UPES on arrival) before starting the actual program of admission. Qualifying TOEFL/IELTS or equivalent may not be mandatory but strongly advised.
- Students must possess a valid passport for the duration of study.

Student can apply online in the prescribed format available at www.upes.ac.in.

An application fee of USD50 is payable applicable for international students. This can be paid online or by credit card. If you experience any difficulties, please request a manual application form from email enrollments@upes.ac.in

UPES will review the student's application and required supporting documents. If found eligible, UPES will issue a Provisional Offer of Admission Letter.

Note: UPES may also request an interview. If the applicant is outside India, this may be by phone or online, the cost of which will be borne by the applicant.

Important note: At the time of final registration, all successful international applicants will be required to submit self-attested copies of the following documents:

- Secondary and Senior Secondary (10th and 12th in the Indian system) grade card or equivalent
- Secondary and Senior Secondary and undergraduate grade card or equivalent for post graduate students.

Students can request assistance from UPES for preliminary registration formalities in Dehradun.
